## Job purpose

To deliver care in accordance with national and local priorities.

## Base

Flexibly across Dartford, Gravesend and Swanley Localities.

## Key responsibilities

This list is intended to summarise the key responsibilities and is not intended to cover every task that may be required of the role:

- To support Physiotherapist or Advanced rehab assistant with running Strength and balance class on every Thursday
- To carry out home visits to support with exercises, review of equipment and to complete Wellbeing assessments, with or without a qualified therapist, as required
- To provide information, teaching and instruction to patients, relatives, carers, other disciplines, and agencies.
- To participate in and support qualified team members in health promotion activities
- To provide clerical and administrative support to the team as delegated by the Lead Therapist.
- To deliver care in accordance with Organisation Policies, procedures and guidelines, according to competencies, as delegated by the Lead Therapist.
- To report any changes in condition of the patient to the Lead Therapist or in their absence the designated therapist in charge of the caseload.
- To respect confidential information obtained in the course of work and refrain from disclosing such information to anyone other than professional staff directly concerned with the patients care or other authorised person.
- To document accurate and concise information on all care given to patients in the community health records.

- To be aware of the Data Protection Act, and follow local codes of practice to ensure appropriate action is taken to safeguard confidential information
- To work with Physios and advanced Rehab assistant within the team to actively support patient rehabilitation programmes, according to care plans created by therapists, following a period of training and when deemed competent to do so.
- To have the ability to work unsupervised, planning and organising tasks and home visits as delegated by the therapist in charge.
- Maintains accurate and legible patient records in line with professional and organisational requirements – this includes electronic patient record system (EMIS) and any paper records
- To take part in surveys and audits as required.
- To attend and actively participate in staff and multi-disciplinary locality meetings.
- To participate in the orientation and induction of new members of staff and students.
- To participate in appraisal and personal development plans to identify and agree training needs.
- To participate in training as appropriate to personal and team skills development.
- To participate in clinical supervision.
- Attend regular 1-1 meetings with Line Manager
- To promote the safety and wellbeing of patients, staff and other persons at all times and assist in ensuring a safe working environment.
- To be responsible for the ordering of equipment and any other reasonable duties as delegated by the Therapist
- To be aware of budgetary issues and the needs for effective use of resources
- To ensure that all complaints, untoward incidents, accidents and areas of clinical risk are identified and reported in accordance with Organisation policies and procedures.
- To maintain knowledge and comply with the Organisation's corporate and local policies and procedures
- To undertake such other duties as may be required from time to time and are consistent with the responsibilities of the role.

This job description is subject to review in consultation with the post holder.

## Confidentiality and Information Security
