Job purpose

Base

The Oldham Total Skin Dermatology clinic is based in the Oldham Integrated Care Centre. The service is open Monday – Sunday.

- This is a very exciting post which covers a wide range of duties and skills which will be taught through practical hands on working, completion of learning criteria and the completion of the Care Certificate. Each member of staff must complete annual mandatory training.

Key responsibilities

- Assist with minor skin surgery.
- Daily recording of room and fridge temperatures and cleanliness
- Ordering of stock
- Monitoring of stock/ unpacking stock
- Restocking of rooms/theatres at the end of day
- Undertaking monthly facilities audits
- Notifying the Line Manager of any damaged equipment.

- Maintenance of accurate medicine stock and records of use (Medicine Management)
