## Job purpose:

To provide comprehensive administrative support to the Team ensuring that work is prioritized in order of urgency and support Team lead and Service Manager. You will also work within the Admin team at the Single Point of Access at Camberley Health Centre.

## Key responsibilities:

- Displays courteous, efficient and robust lines of communication between patients, community staff and other clinicians / external stakeholders e.g. Community nursing, Community hospitals, voluntary sector, GP practices, hospitals, hospice,
- Disseminates service information to staff across the relevant team / designated area as requested using various means of communication: telephone,, meetings via Teams.
- Supports the administration of multidisciplinary / hand over meetings, to include ensuring the availability of appropriate patient records, preparation and distribution of agenda's and associated papers, minute taking for the weekly MDT on a Rota basis with other admin and recording follow up actions, adhering to patient confidentiality and Information Governance requirements throughout.
- Monitoring NHS email inbox and working closely with Ops lead and Triage and tracking referrals
- Awareness of budgetary issues, the effective and safe use of resources.
- Utilizes electronic systems EMIS.
- Order equipment for staff and take charge of ordering all uniforms and ID for existing and new staff.
- Troubleshoot any day-to-day problems within the team / service e.g. liaising with IT providers to ensure seamless IT systems
- Undertake own annual appraisal and attends all mandatory training as required for the role.
- Accesses regular 1-1's with supervisor.
- Networks across the service and liaises with other administrators. Working as part of the Rota, covering a 8-8 service Monday – Friday over 3 shifts (8-4.10-6,12-8PM).

## Confidentiality and Information Security

Monitoring of compliance will be undertaken by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

## Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures
- Understanding key responsibilities outlined in the Information Governance acceptable usage policies and procedures including NHS mandated encryption requirements
- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.

- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

## Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourish. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

## Registered Health Professional
