## This post is responsible for

As a member of the team, we will expect that the successful candidate will be responsible for:

- Carrying out phototherapy, MEDs and supporting and monitoring junior staff
- Being able to assist minor skin operations
- Once trained to carry out scub nurse duties for enhanced procedures, the monitoring and support of junior staff
- Carrying out Photodynamic Therapy
- Post operative wound clinics, able to provide practical and appropriate wound care advice to patients and staff
- Pre-operative patient assessments
- Gathering data for audits and carrying out audits as required
- Liaising with outside organizations to ensure seamless patient care
- Developing leadership skills and able to deputize for senior staff as required. Including 1:1s and appraisals.
