### Job purpose

- We are looking for a compassionate and experienced Senior Nurse to oversee the healthcare provision for children and young people aged 2–19 with severe, profound, and multiple learning and physical difficulties. In this rewarding role, you will offer expert training, guidance, and support to school staff, parents, and carers—ensuring the best possible care for every child.
- You will also take a lead role in managing and supporting the school nurse and assistant practitioner within your team, helping to create a collaborative, nurturing environment where everyone can thrive.

### Key responsibilities

This list is intended to summarise the key responsibilities and is not intended to cover every task that may be required of the role: -

#### **Communication & Collaboration**

- Communicate effectively with children, families, and professionals across education, health, and care settings.
- Use and support alternative communication methods (e.g. Makaton, PECs).
- Handle sensitive and complex information with empathy and confidentiality.
- Build strong relationships with school staff, attend multi-agency meetings, and support team communication.

# **Clinical Judgement & Safeguarding**

- Assess health needs, interpret clinical information, and take appropriate action, including safeguarding.
- Support service delivery through audit, evaluation, and reflective practice.





#### **Service Planning & Organisation**

- Lead care coordination and allocate resources to meet individual needs.
- Provide cover across schools and contribute to developing responsive, high-quality nursing services.

#### **Clinical Skills & Procedures**

- Deliver specialist care including medication administration, tracheostomy care, PEG feeding, and emergency response.
- Use medical equipment with precision and maintain safe driving and basic IT skills.

#### **Patient-Centred Care**

- Deliver holistic, child- and family-focused care.
- Develop and review personalised care plans and empower families in managing health needs.
- Participate in safeguarding processes and multi-agency support networks.

### **Policy & Service Development**

• Promote evidence-based practice, contribute to service improvements, and share best practices locally and nationally.

#### **Resource & Information Management**

- Ensure safe use and availability of medical equipment.
- Maintain accurate, confidential patient and service records, and support IT use within the team.

#### **Team Support & Development**

- Deliver training for school staff and supervise clinical practice.
- Mentor students and support professional development across the team.
- Participate in appraisals, clinical supervision, and contribute to a positive learning culture.

#### **Autonomy & Professional Responsibility**

- Practice independently, recognising risk and making sound clinical decisions.
- Maintain accountability for personal and team standards, ensuring care remains safe, responsive, and child-focused.

# Confidentiality and Information Security

Monitoring of compliance will be undertaken by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

# Information governance responsibilities

- Only using approved equipment for conducting business

#### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

## Registered Health Professional

All staff who are a member of a professional body must comply with standards of professional practice/conduct. It is the post holder's responsibility to ensure they are both familiar with and adhere to these requirements.

### Risk Management/Health & Safety

The post holder has a responsibility to themselves and others in relation to managing risk, health and safety and will be required to work within the policies and procedures laid down by the company. Staff are required to observe the Hygiene Code and demonstrate good infection control and hand hygiene.
