## Job purpose

We are looking for a permanent Band 6 Physiotherapist (Paediatrics) to join our Community Children's Therapy Team in West Essex, covering Uttlesford, Harlow and Epping Forest, to help us continue to change things for the better. Therapy will be delivered in clinic, at several locations in West Essex between Monday - Friday 9am-5pm however we are flexible with these times and offer hybrid working options.

You will work as a key member of the multidisciplinary team to provide physiotherapy assessment diagnosis and treatment for children, and to support them, their families in self-management and care.

## Key responsibilities

Your main responsibilities will include but not be limited to:

- Contribute to departmental development and key performance targets.
- Provide advice on patient care to other health, social care, educational and voluntary sector services. This may involve visiting other establishments such as the child's home, mainstream and special schools, nurseries, and specialist clinics.
- Work with the child, their parents/carers and others involved in the child's care to prioritise treatment aims for the child, including those with complex difficulties and/or terminal illness.
- Develop skills and knowledge with a wide range of MSK and complex disorders, and wider team caseload management under the mentorship of senior colleagues.
- Assess for, recommend, source and train patient and carers in the use of, specialist equipment and orthotics as required, both in the child's home and school
- You will support the development of band 5 physiotherapists and students.

## Job Specification

You will be a qualified Physiotherapist with HCPC registration and have experience of working with children and young people. You will also have experience of assessment and diagnosis within a paediatric setting.

You will be innovative and adaptable, with the ability to work flexibly across specialities as needs arise and a passion for improving the outcomes of children and young people within the local community.

With strong communication and organisation skills, and a flexible approach you will ensure delivery of positive experiences to patients at every stage of their healthcare journey.

As this is a community role, it is essential that you hold a valid UK driving licence and have access to a car for work purposes.
