Job purpose

Key responsibilities

- To work in partnership with patients ensuring privacy and dignity is maintained.
- To assist in promotion of health and wellbeing of patients.
- To undertake clinical interventions as delegate by a clinical team member
- To maintain close liaison with the co-ordinator of the day
- To maintain clear and comprehensive, signed and contemporaneous records according to VCL procedures. To assist with clerical and administrative duties as required
- To work in co-operation with all other professionals and agencies involved in the care of the patient.
- To be aware of and act upon, where necessary, the procedures in place to protect vulnerable individuals.
- To participate in VCL Clinical Governance and Risk Management To undertake and keep updated with all required training, eg Health Care Certificate, mandatory and any additional training

Confidentiality and Information Security

Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

Information governance responsibilities

- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

Registered Health Professional
