Job purpose

This freelance role is about making sure that people's voices, experiences, and stories are truly heard. They will spend time talking with colleagues, patients, families, and carers, collecting their experiences and finding meaningful ways to share these stories. Every patient has a story worth hearing. Behind each appointment, treatment, or visit are experiences that can teach and inspire us.

Base and contract type

The role is a bank contract. It will be home based but will also require travel to services, as and when needed.

This post is responsible for giving colleagues, patients, families, and carers the space to share their stories and create compelling content.

Key responsibilities

- Spend time listening to patients, families, and carers, helping them tell their stories in their own words.
- Collect and share stories in a way that highlights the human impact
- Support patients who may not usually feel heard, making sure their voices are represented.
- Work with staff and teams to make sure stories are shared
- Help organise and support story-sharing events, patient panels, or informal conversation groups both in person and virtually
- Make sure all stories are collected and shared respectfully, safely, and in line with confidentiality and safeguarding.

This description is not intended to cover every task that may be required of the post holder.

Confidentiality and Information Security

Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures
- Understanding key responsibilities outlined in the Information Governance acceptable usage policies and procedures including NHS mandated encryption requirements
- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.





Registered Health Professional
