Job purpose

To work closely with the INT Operational Manager to deliver on all aspects of Integrated Neighbourhood team business, to include providing clinical leadership to the team.

Key responsibilities

This post is responsible for

- To work in partnership with the local Commissioners, GPs and Social Care colleagues
- to ensure the teams deliver and support the effective flow of patients between
- primary community intermediate and secondary care.
- • Work closely with colleagues and lead transformational change whilst at the same time
- maintaining services and meeting all key deliveries.
- • To clinically lead a community team, with a focus on nursing.
- • Develop and maintain positive relationships with key stakeholders, including patients
- and the public all members of staff, local GPs and practice staff, Heads of Operations,
- colleagues from across the 3rd sector, commissioners, local hospital sites and social
- care staff.
- • To provide excellent leadership for an INT, including all staff within the team with a
- primary focus on nursing.
- • To provide effective operational management of the team ensuring that resources
- available are utilised effectively and meet patient needs.
- • Ensure the flow of patients is timely and delays are minimal.

- Use data and soft intelligence to deliver and enhance performance meeting all key performance indicators.
Contribute to the strategic planning including delivery of agreed business objectives.
- To be an ambassador for community services.
- To work collaboratively with INT operations manager to contribute to written reports (financial, activity, workforce, business, intelligence and transformation) including all identification of exceptions and solutions/actions.
- Identify with colleagues' opportunities for service developments and contribute to the delivery of business cases.
- To propose policy changes and support implementation of policies within the Community setting.
- Support the patient safety and quality lead to embed a culture of excellent governance and develop processes for sharing learning from complaints and incidents.
- Work with other INT operational managers across BaNES, Swindon and Wiltshire (BSW) to ensure a consistent approach to the delivery of service across the business unit.
- To effectively manage the team within agreed resources.
- To meet all financial, workforce and Quality targets.
- To support/conduct with clinical incident investigations and disseminate learning to the team.
- Monitor the patient experience and constantly strive for improvement and positive experiences for all patients and their families.
- Deliver the agreed agenda set out within the business plan.
- To have clinical credibility with staff, expected to provide clinical advice and guidance to staff and to ensure the safeguarding of vulnerable adults.
- Using advanced clinical practice skills assess the physical and psychosocial needs of a defined client group.
- To manage, or support other team members, in the case management of patients with complex needs.
- To have the ability to deal sensitively with distressed patients, families, and staff.
- Manage and prioritise the ongoing care of patients involved in case management in a way that ensures the efficient and optimal use of resources so contributing to efficient budget and other resource management.
- Using advanced clinical skills to evaluate the delivery of care, identifying subtle changing health care needs. Be able to competently discuss therapy treatment options with other generalists and specialists.
- Regularly review patient information and documentation that takes into account cultural diversity, and the varying communication needs of patients and users.

- Demonstrate responsibility and accountability for the clinical caseload and co-ordinate care across the whole patient pathway. This includes ensuring a robust relationship and constant interface with secondary care.
- Provide individualised care plan for all patients, so that their condition remains as stable as possible and, where appropriate, hospital admission is prevented, and patient remains within their own home as to their wishes.
- Work in partnership with the patients to empower them to make informed choices about their healthcare and support choices about end of life care.
- Ensure a safe environment for the treatment of clients and protection of staff through risk assessment and by ensuring the effective use of equipment and materials in compliance with health and safety and other relevant policies.
- Work with the Hospital @ Home Team to develop pathways for supporting the individual needs of the patient
- Discuss all treatment options with sensitivity, knowledge and expertise and to act as patient advocate when appropriate and respecting patient confidentiality whilst privacy with respect for diverse cultural backgrounds and requirements.
- Responsibilities for People or Training - Create an open and transparent culture within the team, which supports improvement and innovation.
- Conduct appraisals in line with policy and identify and support individual learning needs of team members.
- Contribute to the workforce plan, including the development of resources and ways of working.
- Manage change effectively with staff of all grades.
- Work with colleagues from across BSW to ensure consistency of workforce development competencies and delivery.
- Manage absence, effectiveness and performance, ensuring all case management is identified and address within the policies and within agreed timescales.
- Support the development of teams to deliver a clinically safe and effective service.
- Role model clinical competency by maintaining own professional development.

- •Flexible working across 24/7 to meet service demands – occasional weekend and out
- of hours shifts may be required
- Ability to drive and travel throughout BSW and beyond.
- Deal with distressed patients and family members.
- Providing professional support and guidance to staff with particular focus online
- management and clinical governance.

- Regular VDU use and ability to concentrate on complex and demanding tasks, whilst taking the lead on governance in key critical areas.
