### Job purpose

The Systems Accountant role will be key as we prepare for growth. We are seeking a highly motivated and experienced Systems Accountant to join our dynamic and fast-paced finance team at HCRG Care Group. This role will play a crucial role in supporting the improvement of our systems, system controls and support in ensuring our finance systems and reporting are efficient. The candidate will provide Dynamics 365 expertise identifying and implementing best in practice changes that will improve our use of our finance systems. The ideal candidate will be a qualified accountant and have excellent communication to ensure success in the role.

## Key responsibilities

- Act as a Finance lead for all system enhancements ahead of upcoming growth.
- Collaborate with IT and Finance teams to identify system requirements needed in D365, Proactis and other systems used by Finance.
- Work through system improvments, provide recomentations and lead implementations.
- Troubleshoot and improve system functionality. Identify root causes, advice on solutions and implement.
- Review current D365 reporting add ons, explore alternatives and implement new add on or improve current.
- Continuously identity and implement changes to improve financial processes within D365 to enchance efficiency.
- Ensure data integrity through controls and identify any improvements required.
- Manage user access, secuirty settings and systems configurations collaberating with IT.
- Train Finance on D365 functionalities provided support to the system users.
- Conduct and plan user testing as part of any deployments of functionality.
- Support the implementation of new systems within Finance and upgrades of current systems.
- Create and maintain documentation of system configurations, customisations and training materials.
- Keep up to date with future system updates.
- Create reports that can be used across Group Finance and Commercial Finance.





• Assist with mobilisation of new services with any finance system related migrations.

#### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes.
