Job purpose

We are the main provider of dermatology services in North and Northeast Lincolnshire. We have been providing a Systemic and Biologics service for patients with chronic skin conditions for over 5 years. We are now in apposition to develop our service and are excited to be able to expand our team.

This post will monitor patients currently prescribed systemic/biologics therapies in accordance with the British Association of Dermatology and NICE guidelines. Support for the role will be provided by the service and our consultants.

Base

This post is primarily based at Cromwell Medical Centre, Grimsby but the post holder will be expected to cover at our other site at Ironstone Centre, Scunthorpe for annual leave/sickness/training

This post is responsible for

Working to set protocols and guidelines

- Monitoring blood levels prior to arranging prescriptions
- Assessing patient condition and recording in notes at each appointment
- Be aware of chronic skin conditions requiring treatment
- Treatment pathways
- Monitoring biological prescriptions and arranging for repeat prescriptions with contracted suppliers
- Liaaising with the entire team
- Be able to deputise for the Band 7 in their absence
- Take part in audits and collate data as required
- Carry out appraisals of junior staff as agreed

- Enrol patients onto the Bluetech system

Key responsibilities

- · Monitoring of patients
- Assisting with the maintenace of the BADBIR and Bluetech registers
- Organization of the caseload in conjunction with the senior nurse
- Education of patients regarding their skin conditions and emotional support of patients
