## Job purpose

## Key responsibilities

This list is intended to summarise the key responsibilities and is not intended to cover every task that may be required of the role:

- To receive goods delivered to HMP Norwich for the health care service
- To transfer goods across both sites at HMP Norwich, delivering to the appreciate site for health care
- To unpack and store all goods into the appropriate storage areas within health care environments
- To manage stock control within all health care sites as directed by line manager
- To ensure a tidy environment is maintained in all storage areas
- To transfer medication between pharmacy and health care areas, adhering to all policies and procedures in the safe transfer of medicines
- To collect specimens form health care sites to ensure they are delivered to the coaction point in time for transportation to laboratory settings

Ensure the confidentiality of all matters relating to patients and information obtained during the course of employment. Undertake other duties as required in keeping with expectations of the grade Generally, resolve day-to-day workload problems using own initiative, in consultation with the line manager as necessary. Participate in in-service training and attend courses and departmental meetings as required. Ensure highest standards of courtesy and efficiency when responding to callers, internal and external organisations and members of the public.

## Confidentiality and Information Security

Monitoring of compliance will be undertaken by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

## Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures
- Understanding key responsibilities outlined in the Information Governance acceptable usage policies and procedures including NHS mandated encryption requirements
- Ensuring the security and confidentiality of all records and personal information assets







- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

## **Registered Health Professional**

All staff who are a member of a professional body must comply with standards of professional practice/conduct. It is the post holder's responsibility to ensure they are both familiar with and adhere to these requirements.
