## Job purpose

To provide patients with care to aid recovery and rehabilitation, following guidance set down by the multi-disciplinary team. To work within a team of health care assistants in ensuring high standards are maintained and new standards are implemented effectively. To support new members of staff, ensuring they are working to the required standards of the ward and wider HCRG Care Group standards.

## Key responsibilities

As a health care assistant you will have some knowledge and experience in care.

We will provide you with additional relevant training and support you to do your job. Your duties will generally be routine in nature and carried out on a day to day basis.

You will have the experience and expertise to work on your own, seeking guidance from registered staff as required.

You will be supervised by registered practitioners on the ward, who will monitor your care and work plans.

Your primary purpose is to carry out routine care and health tasks which will be set out in agreed care plans, or work plans or as directed by registered colleagues.

You will also, when trained, contribute to care plans. Ensuring all documentation is completed accurately.

Tasks will include the provision of personal care and other practical support that will help service users recover, rehabilitate and maintain independence.

Additionally, you will lead/guide a team of health care assistants. Working within HCRG Care Group values and behaviours at all times

## Confidentiality and Information Security

Monitoring of compliance will be undertaken by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

## Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures
- Understanding key responsibilities outlined in the Information Governance acceptable usage policies and procedures including NHS mandated encryption requirements
- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines

- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

## Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

## Registered Health Professional

All staff who are a member of a professional body must comply with standards of professional practice/conduct. It is the post holder's responsibility to ensure they are both familiar with and adhere to these requirements.

## Risk Management/Health & Safety

The post holder has a responsibility to themselves and others in relation to managing risk, health and safety and will be required to work within the policies and procedures laid down by the company. Staff are required to observe the Hygiene Code and demonstrate good infection control and hand hygiene.

Employees must be aware of the responsibilities placed on them by the Health & Safety at Work Act (1974) to ensure that the agreed safety procedures are carried out to maintain a safe environment for other employees, patients and visitors. It is essential to observe strict fire and security precautions at all times.

All staff must report accidents, incidents and near misses so that the company can learn from them and improve safety.

Undertake all aspects of medicines management related activities in accordance with the company's medicines policy where appropriate training has been given and competencies have been achieved.
