## Job purpose

HCA's are to be based within the RGN office or in the clinic rooms. Health care assistants are to ensure high standards are maintained and new standards are implemented effectively.

This list is intended to summarise the key responsibilities and is not intended to cover every task that may be required of the role: -

#### Key responsibilities

- Smoking cessation clinics
- Secondary health clinics
- Other relevant clinics within skill sets as requested.
- Oxygen daily check
- Emergency bag seal check daily
- CD second checks daily
- Daily drop ins on each wing, signing in the wing book on arrival
- Collect the Applications from each wing daily and check there are adequate amounts of healthcare
  applications, concern and compliment forms with the healthcare post box. Also ensure a copy of the
  complaint's procedure is evident on the wall above the box daily.
- Hold a valid HCA response radio (hotel 9 or 10) complete <u>ALL</u> appointments on the ledger for that radio and attend/respond to all calls for that radio.
- When asked, perform all additional duties requested by senior members of staff. If there is a valid
  reason why this can-not be completed it should be discussed between the two members of staff and
  only if absolutely necessary taken to the clinical lead or PIM.
- Be a team player, helping where possible in addition to daily tasks.
- Make sure ALL documentation is completed the same day.
- Make sure any audits assigned to you are completed on time.





- Report relevant incidents on Datix and make your team aware of the issue. Also report on Nomis (incident report) if appropriate. If you do not have access you must arrange this as a matter of importance with the operations manager.
- Make sure the clinic rooms in healthcare daily have been cleaned and restocked ready for the next day.
- Be aware of the policies held on Datix and adhere to them.
- Check HCRG Care group emails and Datix daily for important updates and information.
- Ensure all mandatory training and documents are up to date. This ownership lies with each individual.
- Make sure any relevant clinical issues are raised to a Registered nurse and complete all required referrals for prisoners when required.

### Confidentiality and Information Security

Monitoring of compliance will be undertaken





by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

## Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures
- Understanding key responsibilities outlined in the Information Governance acceptable usage policies and procedures including NHS mandated encryption requirements
- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

#### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

#### Registered Health Professional

All staff who are a member of a professional body must comply with standards of professional practice/conduct. It is the post holder's responsibility to ensure they are both familiar with and adhere to these requirements.





## Risk Management/Health & Safety

The post holder has a responsibility to themselves and others in relation to managing risk, health and safety and will be required to work within the policies and procedures laid down by the company. Staff are required to observe the Hygiene Code and demonstrate good infection control and hand hygiene.

It is essential to observe strict fire and security precautions at all times.
