Job purpose

We are looking for full-time fixed term Administrator to join the Farnham Integrated Care team to help us continue to change things for the better.

You will be working with professionals from different organisations working closely with the Integrated Care Team leader and ICT Coordinator. Other team members include community nursing, social services, mental health, GP practice, proactive case finder, Community paramedics and voluntary services.

You will provide comprehensive administrative support to the ICT ensuring work is prioritised according to need and the office environment is managed efficiently.

This post is responsible for

Being the first point of contact for the team, answering calls, responding to emails and handling enquiries with warmth and professionalism.

Key responsibilities

- Provide day-to-day administrative support to the ICT, including document preparation, scheduling, and updating records.
- Organise and support the multidisciplinary team (MDT) meetings, ensuring relevant patient information is ready and accurate.
- Maintain internal databases, tracking referrals, and assisting with audits and performance reporting.
- Support the ICT Coordinator with project work, service improvements, and operational tasks.
- Use electronic systems (such as SystmOne, EMIS or similar) to update and manage patient information.
- Help new team members get settled with onboarding admin and systems access.
- Handle sensitive information with confidentiality, care and compliance.

- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes.
