## Job purpose

The role will play a vital part in ensuring the smooth day-to-day operations, supporting contract administration, data reporting, internal communications, and staff engagement initiatives. This is an exciting opportunity to contribute to the success of a dynamic healthcare team making a real difference in patient care and well- being.

As travel to services may be required for this role, a UK driving license and access to a car will be required.

## Key responsibilities

### **Administrative Support**

- Schedule and coordinate meetings, including preparing and distributing agendas and taking accurate minutes.
- Manage calendars and diary commitments for our Strategic Lead and Practice Educator.
- Arrange travel and logistics for our Practice Educator.
- Format reports and documents in line with company branding guidelines.
- Maintain and organise digital filing systems, particularly on Microsoft Teams.
- Regularly post good news and updates on the internal communication platform to highlight achievements and foster engagement.

### **Contract Administration Support**

- Liaise with internal departments to gather and compile key contractual information.
- Support the preparation of contract-related documentation and final drafts.
- Maintain and update contract trackers to ensure they are current and accurate.





### **Data Management & Reporting**

- Maintain up-to-date reporting dashboards and performance logs.
- Prepare key data and reports ahead of meetings, highlighting areas of concern or non-compliance to the Strategic Lead.
- Assist in tracking business unit KPIs and performance indicators.

## **Confidentiality and Information Security**

## Information governance responsibilities

- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines
- Only using email accounts authorised by us. These should be used in accordance with the Sending and Transferring Information Securely Procedures and Acceptable Use Policies.
- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.
