### Job purpose

To work within a multi-professional team in an Inpatient setting, providing, support, care, and treatment to individuals, within guidelines and protocols identified for the role.

This post is responsible for

#### Key responsibilities

- To implement treatment by following care plan.
- To keep the patient at the centre of his or her care, ensuring patient and carer participation in decision making.
- To undertake the daily care and support of delegated patients.
- Deliver treatment/care within an Inpatient setting as specified in a written care plan, under the guidance of a registered practitioner.
- Responsibility and supporting the day-to-day care of patients including monitoring.
- To have a good knowledge of infection control, to reduce risk of health care acquired infections.
- To enable patients to reach their optimum level of independence.
- To communicate with individuals about routine and daily activities, this may include overcoming difficulties (e.g. hearing/language).
- To ensure the needs and wishes of the individual are documented.
- To work within a multi-professional team
- To undertake specific tasks as delegated.





- To assist registered and junior staff, referring to registered staff when necessary.
- Assist in dressing and fracture clinics
- Support the administrative staff with some administrative duties
- To practice the principles and philosophy of individualised patient care in accordance with policy, procedures and regulatory body's guidelines.
- To obtain consent for any treatment undertaken.
- Request a chaperone when appropriate or be a chaperone for patients when requested

## Confidentiality and Information Security

Monitoring of compliance will be undertaken by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

### Information governance responsibilities

- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

#### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.

## Registered Health Professional
