Job purpose

We are looking to recruit an enthusiastic Occupational Therapist to Join our MDT workforce providing inpatient rehabilitation for patients with stroke, longterm neurological conditions and care of the elderly.

The post is based on Runfold Ward at Farnham Hospital, Surrey. The post available is flexible to the appropriate candidate and agreement on appropriate support required will be discussed at interview. If you feel you would like the challenge of being part of a multidisciplinary team who are passionate about rehabilitation then this could be the post for you.

Agenda for Change Terms and Conditions

Key Responsibilities

The Occupational Therapist will provide intervention as part of a multi-disciplinary rehabilitation approach to meet the health and social care needs of the patients. He/she will be support a caseload and will be responsible for assessment, treatment, discharge planning and long-term management advice to these patients. You will be supported at all times by OT colleagues.

The role includes

- To undertake assessment of patients in a timely manner – as per clinical guidelines.
- (With support of senior colleagues if required) assess and plan appropriate treatment interventions for patients in subacute phase of stroke rehabilitation, complex acute or chronic conditions.
- To devise, implement and evaluate patient centred treatment plans

Job Description

- To ensure that the individuals full potential and functional independence has been achieved with the appropriate provision of equipment if required.
- To communicate effectively to the multi-disciplinary team to promote patient safety and the management of risk. To work with adult social care professionals on discharge planning
- To liaise with family and carers in a sensitive way maintaining confidentiality.
- To participate in training and supervision of OT assistants within the speciality.
- To monitor and improve standards of care through supervision and reflection on own practice.
- To participate in evidence based projects and implement recommendations for change. To be involved in service developments with the support of the senior staff
- To be responsible as an autonomous practitioner to undertake a clinical workload (with support if required).

Planning and organisational tasks / duties

- To be able to prioritise case load when required, responding to urgent referrals and occasionally unpredictable work patterns.
- To work as part of the Occupational Therapy team to provide an efficient and effective service demonstrating resilience in challenging times.
- To attend relevant wards rounds, meetings and case conferences as appropriate in order to ensure appropriate management, support and effective timely discharge of patients.
- To delegate and plan workload with the OT assistants.
- To develop skills in managing own diary in ensuring an appropriate balance of clinical and other responsibilities. To develop skills to prioritise effectively and be flexible in changing tasks when dealing with emergencies.
- To work collaboratively with patients on the provision of equipment and resources
- To participate in service related and group meetings where appropriate, planning, organising, chairing or minute taking when required.

Professional responsibilities

- To be responsible for maintaining own CPD keeping upto date with new trends and developments, especially In relation to evidenced based practice.
- To participate In the development and training of Occupational Therapy assistants.
- To participate In clinical supervision and annual staff appraisal scheme.
- To participate In service development projects and audit
- To ensure membership of appropriate professional bodies remains upto date - HCPC and to have knowledge of standards required
- To participate and maintain upto date statutory and mandatory training relevant to the role.

General

- This Is a varied role where a degree of flexibility Is required to ensure we can provide an equitable service, working with colleagues and line manager to ensure that the activities of the post make a real difference to out patients.
- Depending experience this post may require occasional weekend working.
- The post holder must hold a valid driving licence.
- We provide support through clinical supervision, In-service training, Journal reviews and preceptorship programmes.
