## Job purpose

This is an exciting new post within our growing dermatology service. With incidence of skin cancers increasing over the entire country and within our region, we are looking to develop this new post within the service. In line with the British Association of Dermatologists, NICE and the British Dermatological Nursing Group guidelines we are looking for a person who is willing to go the extra mile for their patients.

## Base

We are the biggest provider of dermatology services across North and Northeast Lincolnshire. We hold clinics at the Ironstone Medical Centre, Scunthorpe, Cromwell Medical Centre, Grimsby, and Freshney Green Medical Centre, Grimsby. We are all expected to work across all three sites as required.

## This post is responsible for

The post will include: viewing all histology results, posting relevant patients for discussion at MDT, liaising with the MDT Co-ordinator, attending the weekly Skin MDT meetings, meeting patients to discuss their diagnosis and attending appointments with the dermatology consultants for more serious diagnosis. To provide emotional support to patients throughout their time in our care.

- Development to Lesion diagnosis/ involvement in 2ww clinics
- Post operative wound care as required
- Pre-operative assessments as required
- Developing skills and completing competencies, PDP plans
- Deputising for Band 7 in their absence
- Carry out appraisals of junior staff as required
- To collate data and complete audits
- Duties as required as part of the wider team

## Key responsibilities

- To liaise with patients and colleagues to ensure that all patients receive a high quality of care
- Be the essential nursing presence in MDT meetings
- Monitor returned histologies.
- To be an active member of the team and provide assistance and guidance to other members of staff
- Educate patients regarding sun induced skin cancers, skin protection
- To continually develop the role in line with the needs of the patients and service.
