## Job purpose

We are seeking a high organised and people-focussed Project Co-ordinator to join our team. This role will support the delivery of a complex programme of work within the organisation's change portfolio. The post holder will be responsible for ensuring the smooth running of the programme through diligent management of key documentation, co-ordination of meetings, and reporting progress of workstreams at project and programme board meetings.

The role requires collaboration within a multi-disciplinary project team, as well as clinical operational teams and other stakeholders both inside and outside the organisation.

#### **Base**

This is a predominantly remote role, with occasional need to travel into HCRG Care Group offices or delivery sites.

## Key responsibilities

- Project planning and scheduling Assisting the Project and Change Lead as well as Subject Matter Experts (SMEs) from across the organisation in the development and maintenance of the project plan, ensuring tasks are tracked effectively.
- Communication and coordination Acting as a point of contact within the Project Management Office
  for internal and external stakeholders. Requesting information from SMEs, communicating and
  managing adherence to deadlines. Coordinating diaries and booking meetings between key
  stakeholders.
- Documentation and reporting Preparing and maintaining project documentation including update reports, risk logs and action logs. Compiling highlight reports to be presented to senior leaders within the organisation.
- Risk and issue management Identify potential risks and issues and work with the Project and Change Lead to develop mitigation strategies.

- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes.
