Job purpose

Base

Our service covers North and Northeast Lincolnshire area, and we provide Dermatology and Skin Cancer care. We run our clinics from Cromwell Rd, Grimsby and Ironstone Centre Scunthorpe. We are a Community based secondary care service offering a full range dermatology related specialist care services.

Job Introduction

The receptionist will work within both sites. Shifts vary from 8-5.30 Monday – Friday .

The main duties of the post:

- Meet and Greet patients for all Dermatology Appointments
- Outcome all appointments, typing and sending clinical letters to GP practices and local trusts
- Prepare and clear down clinical rooms.
- Prepare and clear down reception area
- Prepare administration for the day - ensure any gaps are filled for the day and appropriate paperwork is complete
- Upload all documentation from clinics, including medical photography, paperwork, Incoming and actioned post
- Cancellation reports from confirmation text messages
- Action generic mailbox appropriately
- Ensure processes are followed for patients who do not attend or are not brought - In line with local policy and SOP's

- Review tasks on EMIS to ensure all are actioned appropriately.

The above list is not exhaustive, and the post holder will be required to undertake any other task reasonably expected or requested by his or her line manager.
