## Job purpose

The Neuro Diversity Inclusion Facilitator will play a pivotal role in the Partnerships for Inclusion of Neurodiversity in Schools (PINS) project, aimed at enhancing outcomes for neurodiverse students in mainstream primary schools. The facilitator will work closely with education, health specialists, and expert parent carers to shape whole school SEND provision, provide early interventions, upskill school staff, and strengthen partnerships between schools and parent carers.

Base: Area based but agile to meet the needs of Children and Young People

#### Key responsibilities

- Collaborate with education, health specialists, and parent carers to assess and shape whole school SEND provision.
- Provide early interventions and support at a school level, tailored to the needs of neurodiverse students.
- Deliver high-quality training sessions to upskill school staff in neurodiversity awareness and effective teaching strategies.
- Strengthen partnerships between schools and parent carers through regular communication, workshops, and collaborative initiatives.
- Develop schools' confidence and expertise in supporting neurodiversity within classrooms through consultation and practical assistance.
- Identify and implement strategies to improve the school environment to better accommodate neurodiverse students' needs and enhance their engagement in learning.
- Foster an inclusive culture within schools that amplifies the efficacy of other interventions and promotes the well-being of all students.

#### Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. - Passion for inclusion and a commitment to promoting positive outcomes for neurodiverse students in mainstream education.
