Job purpose

- Central point of contact for DCO/DMO (Designated Clinical officer/Designation Medical officer)
 queries. This could include Tribunal requests and information required from Education Legal
 Department, requests for advice from partners in education, external partners and parents.
- To assist with any relevant data collection e.g., for SEND (Special educational needs and disability) dashboard, other data relevant to evidence compliance with DFE guidance.
- Administration support for the DCO/DMO including presentations or reports required for role.
- Administer the EHCNA advice request process.

Base

The base of operations for this role will be the Florence Nightingale Child Development Centre in Harlow. However, the role may require travelling to and working from our other delivery hubs or offices in West Essex.

This post is responsible for

- Maintaining and co-ordinating shared DMO/DCO diary, includes keeping a full log of meetings (type & frequency of regular meetings as well as ad hoc requests), assisting with managing and coordinating attendance from relevant DMO/DCO team, sending meeting requests and managing responses, may be involved in some minute taking
- Maintaining a full record of DMO/DCO activity to ensure that everything is captured for reporting/inspection purposes, including assisting with any subsequent action plans, as appropriate (e.g., ensuring that any new guidance and information is shared across teams, any changes in practice /SOPs are actioned)
- Monitoring of DMO mailbox & escalating relevant queries for response in appropriate timeframes.
- Ensuring a timely response to EHCNA requests across all the West Essex specialist services.
- Liaising with other services and professionals to collect information relating to the DCO/DMO role.
- Liaise closely with parents and guardians of patients for correspondence, appointments, information.
- Logging all information onto SystmOne, including appointments, referrals, post, telephone information, contact details, maintaining a high level of accuracy and tact.

Governance
