## Job purpose

- To be responsible for the continued development of safe, effective, evidenced based Tissue Viability Services across the local organisation.
- Provide specialist Tissue Viability advice and support to Nursing staff and other professionals.
- To contribute in the educational programs, to enable Nurses and other professionals to undertake a range of Tissue Viability treatment programs, safely meeting patients' needs and supporting integrated care pathways.
- To promote the service within the Primary setting, liaising with other organisations as necessary and supporting the evaluation of outcomes and effectiveness to develop the Service.
- To assist in ensuring policies are always kept up to date.
- To deputise for the Lead Tissue Viability Nurse Specialist as required.
- To take the lead role across the Service on specific projects as directed and supported by the Lead Tissue Viability Nurse Specialist.
- To provide caseload leadership and management that demonstrates quality, safety and productivity in line with commissioning intentions.
- Act as a role model for the delivery of high standards of care that complies with NMC codes of conduct and Trust policies.
- Document all patient interventions into electronic record ensuring accuracy and the inclusion of all appropriate assessments, as soon as possible following visit.
- Ensure correct use of confidential and sensitive information in line with Caldicott.

## Key responsibilities

### Knowledge, training, and experience

- First Level Registered Nurse
- Minimum of three years' experience in relevant field
- Relevant Wound care and Leg Ulcer care experience
- Teaching and Assessing NMC approved qualification (e.g., ENB 998 or equivalent)
- Evidence of relevant post registration specialist continuing professional development
- Evidence of supervising/leading staff
- Experience of managing own caseload and working autonomously
- Evidence of being able to clinically manage complex cases.
- Excellent verbal and written communication skills
- Competent knowledge of IT and electronic communication
- Good interpersonal skills
- Flexible approach
- Display professional behaviours in line with HCRG values

### Communication and Relationship Skills.

- Ensure that complex issues are shared appropriately when communicating with external stakeholders and other providers.
- Liaise effectively with other team members and healthcare professionals in accordance with the patients care plan to ensure that it meets with the agreement of the patient to gain concordance.
- Deliver effective communication with patients/carers, to discuss sensitive and complex information in relation to their individual needs and programmes of care such as end of life, chronic disease management or Safeguarding Vulnerable Adults.
- Provide clear and articulate, well considered information to enable patients/relatives to make informed choices for their care
- Use effective communications that supports, directs, encourages, and motivates individual staff during daily work and team meetings.
- Receive referrals from Care Co-ordination Centre (CCC) and triage the information to prioritise, offer initial advice, allocate necessary visits, and manage your own time to support the service.
- Display exemplary professional behaviour in keeping with HCRG values and behaviours whilst managing the caseload.

- Be computer literate to access and update computerised patient records.
- Provide and receive highly complex and sensitive information, using a variety of methods to ensure effective understanding.
- To be skilled at making presentations and delivering same at local / regional meetings to all members of the multidisciplinary team to share best practice.
- To act as the intermediary between Acute Hospital Services and the Community.

## **Analytical and Judgement skills**

- The post holder will assess and interpret the clinical condition of patients to devise person centred care plans and will analyse the effectiveness, adjusting care as clinical status indicates
- To be able to present accurate and relevant information to the service user, Senior Sister and other team members, Community Matrons and Specialist Nurses.
- Act as a role model to provide effective leadership, ensuring competent, safe practice and adequate caseload cover, liaising with the Team Lead, LTC Nurses and other Specialist Nurses as necessary.
- Support the Senior Sister to manage urgent clinical issues as they develop e.g., crisis management of both staff and patients. Develop coping strategies for dealing with stressful situations with support from senior colleagues.
- Be responsible and accountable for ensuring caseload assessments are reviewed according to clinical need.
- Identify clinical risk issues and make recommendations for appropriate action.
- Review national information and recommend how this can be implemented locally.
- Assist on setting standards and measuring outcomes, also clinical audit as required.
- Act on medical advice alerts.
- Assist with Safeguarding screens and SBARS, ensure as appropriate to TVN team findings are implemented.

## **Planning and Organisational skills**

- Plan and organise patient centred care according to individual needs and evaluate care according to the evidence provided by the team.
- Undertake the role of educator in clinical practice across defined areas of expertise and be approved competency assessor within these clinical areas such as, Wound Care, lower limb ulceration and Pressure Ulcer Management.
- Attend one to one's, appraisal and clinical supervision as required.

- Plan and organise own work according to need and be able to work with an unpredictable work pattern.
- Plan, organise and deliver educational packages to health care professionals.
- Participate in the informal support and educational needs of health care professionals and carers to ensure that competency is achieved.
- Take a lead role across the Service on specific projects as directed by the Lead Tissue Viability Nurse Specialist.
- Assist the Lead Tissue Viability Nurse Specialist with cover during unforeseen peers' absence.

## Physical Skills

- Good IT Skills including Microsoft Office and Web based systems e.g., DATIX, Caseload Management, emails, Excel.
- Full Driving license and access to Car.
- Manual handling of patients as required.
- The role will involve bending, kneeling, and stretching whilst occasionally handling and / or transporting equipment, manual handling of patients.
- There will be some requirement of physical effort in relation to patient care.
- Some long periods of computer use. To have the manual dexterity to perform tasks e.g. bandaging, removal of sutures.

## Responsibility for Patient/Client Care

- Provide highly specialised clinical advice and support to staff and patients, relatives and carers relating to Tissue Viability, liaising with staff / colleagues as appropriate across both Acute and Community Services.
- Analyse situations and consider all options of therapeutic interventions before making treatment decisions, including referring to other services, if required for example Lymphedema and Podiatry.
- Utilise the Risk Assessment Tools to analyse the risk of admission of the most complex patients and assess and develop Care Plans to prevent unnecessary hospital admission.
- Participate in multi-disciplinary meetings with GPs
- Based on identified need make requisitions for items of home loan equipment, refer to and liaise with other agencies as appropriate.
- Be aware of and act on any safeguarding concerns in line with policy and procedures.
- Where applicable, prescribe products to meet needs of patients utilising independent prescribing in accordance with own scope of practice.

- Be responsible for patient/client care in relation to the Mental Capacity Act. Liaise and work closely with all agencies and health care professionals involved in the patients care either internally or externally.
- Maintain up to date knowledge base and skills which reflect local need and evidence-based approach to practice. Following appropriate training, maintain competencies in a wide range of clinical skills encompassing all specialties needed for working within the Long-Term Service.
- Deliver or appropriately delegate a range of clinical interventions exercising accountability according to individual competence and confidence.
- To provide clinical advice to the team that is evidence based and in accordance with HCRG policies and protocols.
- Support the team to ensure that HCRG policies and procedures are adhered to in all areas of practice.
- Ensure that patient confidentiality is maintained and that Caldicott principles are adhered to.
- Ensure that incidents are reported in a timely manner and action plans developed to reduce repeated risks.
- To provide sound clinical advice to health care professionals, patients and families on aspects relating to Tissue Viability, and pressure relieving equipment.
- To highlight service risks to Lead Tissue Viability Nurse Specialist and discuss risks as they arise with the team.

## **Responsibilities for policy and service development implementation**

- Support the creation of a learning/development environment for team members and allocated students ensuring a positive work environment is maintained.
- Undertake preceptorship, mentorship, workplace assessor and teaching roles to ensure the team is supported.
- Assess clinical staff against specific competencies to ensure professional standards are being delivered when appropriate.
- Take responsibility for the teaching of, and giving information to, patients and their families so they may be able to make informed decisions for their care.
- Identify the need for teaching programmes for carers and to work with others in demonstrating nursing care procedures where appropriate.

## **Responsibilities for financial and physical resources**

- Be an effective prescriber and be aware of the financial impact of prescribing. The post holder has a responsibility to ensure that resources are used appropriately and cost effectively (i.e.

mobile phones, dressings) according to HCRG policy and that inappropriate use of resources is reported to the appropriate person.

## **Responsibilities for Human Resources**

- To review and reflect on own performance through effective use of clinical supervision and appraisal.
- Undertake all training as required on the relevant training matrix, including Mandatory and Essential to role.

## **Responsibilities for Information Resources**

- Provide and keep statistical information as required by Senior Sister and senior management team.
- Maintain systems of monitoring as required by HCRG.

## **Responsibilities for Research and Development**

- Contribute to new ways of working and practices within the team and wider locality as required.
- Contribute to the collection of data pertaining to research and audit as required, such as CQUIN.
- Undertake audits for peer services to establish benchmarks and areas for improvement.

## **Freedom to Act**

- The post holder is required to be accountable for his/her own actions, to act on his/her initiative and to be aware of the impact on others
- Maintain active status on the NMC register always working within the NMC code of conduct and professional guidelines.
- To ensure delivery of high standards of care via the day-to-day management of the team.
- In accordance with HCRG policies and professional accountability, provide autonomous skilled nursing care to patients in the community, adapting to a changing workload throughout the day.
- Maintain safe standards of practice by being familiar with all current professional, local and NHS issues, attending meetings/courses as identified and appropriate.
- Practice, where appropriate as an Independent Prescriber within own scope of practice.

## **Working Conditions**

- Work as part of a team but without direct supervision.

- Occasional exposure to verbal aggression (telephone/face to face)
- Frequent need to provide and receive sensitive information
- Frequent exposure to wounds and bodily fluids
- Regular requirement to drive
- Regular use of computers to access emails and systems

## Confidentiality and Information Security
