Job purpose

To be responsible for administrative duties in relation to the Teesside Sexual Health Service. To assist with the provision of the sexual health service and contribute to the effective running of the clinics through the delivery of administrative tasks which directly support the service and by maintaining administrative systems and procedures including reception duties, back-office support, manage incoming calls from the 'call centre' and action as required and through direct patient contact.

Key responsibilities

- Reception desk duties including greeting and registering patients, booking appointments and handling general enquires from patients, other healthcare professionals and the public where appropriate.
- Manage incoming calls from the 'call centre' and action as required.
- To assist with the distribution of mail and notices as required.
- Send appointment reminders for all sites.
- Check for unallocated postal test results and match them to the corresponding patient record or action as necessary.
- Run reports from clinical system.
- Book any required translators for appointments.
- Process postal test results.
- Management of patient and records and results.
- To maintain high standards of data quality.
- Production of letters as required.
- To assist in the inputting of data into the clinical system.
- Recording of messages for clinical staff, ensuring that they are accurate and passed the appropriate party.
- To deal effectively with incoming and outgoing post.





- To assist with filing and management of patient records and information.
- Support the administration of spoke clinics.
- Support the sexual health call centre as required.
 The post holder will:
- Be able to prioritise workload and use own initiative.
- Work flexibly in response to the needs of the service.
- Undertake any additional duties as required;
- Liaise with management and VH team to resolve any problems/issues with postal/express testing.

Monitoring of compliance will be undertaken





by the Company. Failure to adhere to Information Governance policies and procedures may result in disciplinary action and, where applicable, criminal prosecution.

Information governance responsibilities

You are responsible for the following key aspects of Information Governance (not an exhaustive list):

- Completion of annual information governance training
- Reading applicable policies and procedures

- Ensuring the security and confidentiality of all records and personal information assets
- Maintaining timely and accurate record keeping and where appropriate, in accordance with professional guidelines

- Reporting information governance incidents and near misses on CIRIS or to the appropriate person e.g. line manager, Head of Information Governance, Information Security Lead
- Adherence to the clear desk/screen policy
- Only using approved equipment for conducting business

Governance

Clinical governance is a framework through which organisations delivering health and care services are accountable to continuously improving the quality of their services and safeguarding high standards of care by creating an environment in which clinical and other forms of care flourishes. Employees must be aware that clinical governance places a duty on all staff to ensure that the level of care services they deliver to patients is safe and high quality, and that they follow/comply with our policies and procedures.
